For years, AmericanChecked recognized that there was a deficiency in the laws in the state of Nevada that prevented background screeners from reporting all convictions past seven years, including violent offenses and theft. AmericanChecked introduced Senate Bill 409 in partnership with Tony Cabot at Lewis Roca Rothgerber and sponsored by former Nevada Gaming Control Board Chairman and State Senator Mark Lipparelli that changed the landscape of what is now reportable in Nevada for the whole industry. With the passage of SB409, businesses, their employees and their patrons enjoy greater protections as CRA’s are now able to report criminal convictions older than 7 years to all employers and reporting information to gaming licensees about a job applicant regarding bankruptcies older than 10 years and other civil judgments older than 7 years.
